## ORDINANCE OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF GLOUCESTER AMENDING CHAPTER 67A, ARTICLE IV OF THE PROPERTY MAINTENANCE

**BE IT ORDAINED** by the Township Council of the Township of Gloucester, County of Camden, State of New Jersey that Chapter 67-A of the Code of the Township of Gloucester be and is hereby amended as follows:

SECTION 1. CHAPTER 67A Section 2A Registration Certificates

The applicant may be refused if such investigation reveals the following:

- 1. Conviction involving crimes of a sexual nature or endangering the welfare of children at any time;
- 2. Conviction of any crime involving arson, aggravated assault, burglary, embezzlement, conspiracy, conversion and misappropriation of funds, extortion, larceny,

loan sharking, possession or use of a controlled dangerous substance, and other crimes occurring in the past 10 years;

Or a conviction of a disorderly persons or petty disorderly persons offense within the past three years.

#### SECTION 2. CHAPTER 67A Section 6A Regulations

(A) The following regulations apply to all structures that are being secured (boarded – up) by property owners, hired vendors, lien holders, insurance company or governmental agencies. All board-up shall be completed within 72 hours. Any boards or other materials that are used to secure windows, doors, or other openings in any structure shall be painted white and shall have applied to them a light gray grid as shown on the attached sketch. Except in the case of emergency requiring immediate board up plain board material may be used but replaced and the structure shall be painted white with a light gray grid applied as shown on the attached sketch within 72 hours.

<u>SECTION 3.</u> All ordinances and provisions thereof inconsistent with the provisions of this Ordinance shall be and are hereby repealed to the extent of such inconsistency.

<u>SECTION 4.</u> If any section, subsection or part, clause or phrase of this Ordinance shall be declared invalid by judgment of any court of competent jurisdiction, such section, subsection, part, clause or phrase shall be deemed to be severable from the remainder of the ordinance.

<u>SECTION 5.</u> This Ordinance shall take effect immediately after final passage and publication as required by law.
