GT E-GOV ACCESS

Peter Heinbaugh of 2 Morningstar Court, Sicklerville, NJ asked the following questions:

On the bill list, vendor ALL COVERED was paid over \$17,000. What work did they do for GT for that \$17,000? Please explain the nature of the existing contract between ALL COVERED and GT. Has the volume and/or scope of contracted work from ALL COVERED for GT increased in the past year or two?

Mr. Mercado stated All Covered provides IT services remotely on-site for the township. In their initial proposal, it was \$5,891.60 a month. They provide IT services remotely and on site for the Police as well at a per hourly rate. Over the last two to three years the services have expanded. Originally the Police Department had in house IT Department. That has expanded from non-police to also include non-police and police for technology needs for the municipality.

On the bill list, \$19,000 was paid to BLUESKY POWER. Please explain the work done for this payment.

The actual bill was for \$19,187.00. It covers the period of July 21st to October 1, 2017. The invoice has a list of projects that Bluesky works for. Bluesky is our energy consultant. They are working on GEMS Landfill Solar Energy Project with the township, township solar projects which includes the schools, PPA, bill analysis and recs, the general energy committee, their programs and also the Owens Corning Landfill Solar Project. Their hours included on our invoice which totals \$19,187.00.

Regarding R-17:10-279, please explain this new position – EMERGENCY MEDICAL SERVICES. This is not a new position. We require and go out for an RFP/RFQ for Emergency services, those who are providing ambulances for our township. The last time a proposal was received was November 7th of 2012. It is a 5 year contract that is mandated by the state that sunsets on December 31, 2017. So this going out for an RFP/RFQ for the most responsible proposal determined by the township council.

PUBLIC PORTION:

Mr. Mercado opened the public portion.

Ray Polidoro of Erial welcomed the scouts. He spoke about the passing of Marge Martinis and Eric Lawrence. He also commented on the response of the Gloucester Township Police Department and the First Responders to the accident on Sicklerville Road this past weekend.
