RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF GLOUCESTER, COUNTY OF CAMDEN, NEW JERSEY AUTHORIZING AND APPROVING THE **ISSUANCE AND SALE OF UP TO OF \$1,600,000 OF BONDS** OF THE TOWNSHIP OF GLOUCESTER CONSISTING OF THE TOWNSHIP'S GENERAL OBLIGATION BONDS, SERIES 2016A, AND THE TOWNSHIP'S GENERAL **OBLIGATION BONDS, SERIES 2016B; AUTHORIZING** THE EXECUTION AND DELIVERY OF THE LOAN AGREEMENTS TO BE EXECUTED BY THE TOWNSHIP AND EACH OF THE NEW JERSEY ENVIRONMENTAL INFRASTRUCTURE TRUST AND STATE OF NEW JERSEY, ACTING BY AND THROUGH THE NEW JERSEY DEPARTMENT OF ENVIRONMENTAL PROTECTION; FURTHER AUTHORIZING THE EXECUTION AND DELIVERY OF AN ESCROW AGREEMENT, ALL PURSUANT TO THE 2016 NEW **JERSEY ENVIRONMENTAL INFRASTRUCTURE** TRUST FINANCING PROGRAM; AND DETERMINING CERTAIN **OTHER MATTERS IN CONNECTION THEREWITH**

WHEREAS, the Township of Gloucester, County of Camden, New Jersey ("Township") has determined there exists a need for the Completion of Various Improvements to the Storm Water Drainage System ("2016 Project"), as described in that certain Loan Agreement ("Trust Loan Agreement") to be entered into between the Township and the New Jersey Environmental Infrastructure Trust ("Trust") and that certain Loan Agreement ("Fund Loan Agreement"; together with the Trust Loan Agreement, the "Loan Agreements") to be entered into between the Township and the State of New Jersey, acting by and through the New Jersey Department of Environmental Protection ("State"), all pursuant to the 2016 New Jersey Environmental Infrastructure Trust Financing Program ("Program"); and

WHEREAS, the Township has determined to use the proceeds of a loan to be made by

each of the Trust ("Trust Loan") and the State ("Fund Loan"; together with the Trust Loan, the "Loans") pursuant to the Trust Loan Agreement and the Fund Loan Agreement, respectively, to permanently finance the 2016 Project; and

WHEREAS, to evidence the Loans, each of the Trust and the State require the Township to authorize, execute and deliver its General Obligation Bonds, Series 2016A, to the Trust ("2016A Bonds") and its General Obligation Bonds, Series 2016B, to the State ("2016B Bonds"; together with the 2016A Bonds, the "2016 Bonds"), pursuant to the terms of applicable law and pursuant to the terms of the Loan Agreements; and

WHEREAS, pursuant to the Local Bond Law, constituting Chapter 169 of the Laws of 1960 of the State of New Jersey, as amended and supplemented ("Local Bond Law"), the Township Council has, pursuant to Bond Ordinance No. O.15.16, duly and finally adopted and published in accordance with the requirements of the Local Bond Law ("Bond Ordinance"), authorized the issuance of general obligation bonds or bond anticipation notes of the Township to finance the costs of the 2016 Project; and

WHEREAS, the Trust and the State have expressed their desire to close in escrow the making of the Loans, the issuance of the 2016 Bonds and the execution and delivery of the Loan Agreements, all pursuant to the terms of an Escrow Agreement ("Escrow Agreement") to be entered into between the Trust, the State, the Escrow Agent and the Township; and

WHEREAS, to effectuate the financing plan described in the above mentioned paragraphs, it is necessary for the Township to adopt this resolution and to authorize and approve the issuance and sale of the 2016 Bonds in a principal amount up to \$1,600,000; and

WHEREAS, *N.J.S.A.* 40A:2-27(a)(2) allows for the sale of the 2016A Bonds and the 2016B Bonds to the Trust and the State, respectively, without any public offering, and *N.J.S.A.* 58:11B-9(a) allows for the sale of the 2016 Bonds to the Trust, without any public offering, all under the terms and conditions set forth herein.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF GLOUCESTER, COUNTY OF CAMDEN, NEW JERSEY, PURSUANT TO THE LOCAL BOND LAW (NOT LESS THAN TWO-THIRDS OF ALL THE MEMBERS THEREOF AFFIRMATIVELY CONCURRING), AS FOLLOWS:

<u>Section 1.</u> The Township authorizes and approves the issuance of the 2016 Bonds in two series (2) in a total principal amount of up to \$1,600,000 to be designated, "Township of Gloucester, County of Camden, New Jersey, General Obligation Bonds, Series 2016A" and "Township of Gloucester, County of Camden, New Jersey, General Obligation Bonds, Series 2016B", respectively. The 2016 Bonds will be used to pay the costs of the 2016 Project. In accordance with *N.J.S.A.* 40A:2-27(a)(2) and *N.J.S.A.* 58:11B-9(a), the Township hereby sells and awards the 2016A Bonds and the 2016B Bonds to the Trust and to the State in accordance with the provisions hereof.

Section 2. The Chief Financial Officer is hereby authorized to determine in accordance with the Local Bond Law and pursuant to the terms and conditions established by the Trust and the State under the Loan Agreements and the terms and conditions hereof, the following items with respect to the 2016A Bonds and the 2016B Bonds:

- (a) The aggregate principal amount of the 2016A Bonds and the 2016B Bonds to be issued;
- (b) The maturity and annual principal installments of the 2016A Bonds and 2016B Bonds, which maturity shall not exceed thirty (30) years;
- (c) The date of the 2016 Bonds;
- (d) The interest rates of the 2016 Bonds;
- (e) The purchase price for the 2016 Bonds; and
- (f) The terms and conditions under which the 2016 Bonds shall be subject to redemption prior to their stated maturities.

Any determination made by the Chief Financial Officer pursuant to the terms hereof shall be conclusively evidenced by the execution and attestation of the 2016 Bonds by the parties authorized under Section 3 hereof.

Section 3. The 2016 Bonds shall be in the form prescribed and permitted by the Local Bond Law, as Bond Counsel may advise, and as the Township, the Trust and the State shall approve. The 2016 Bonds shall be issued in fully registered form and shall be payable to the registered owners thereof as to principal and interest in lawful money of the United States of America. The 2016 Bonds will be executed on behalf of the Township by the manual signatures or facsimile signatures of the Mayor and Chief Financial Officer, attested by the Township Clerk (such execution shall constitute conclusive approval by the Township of the form of the 2016 Bonds), and shall bear the affixed, imprinted or reproduced seal of the Township thereon. The

2016A Bonds and the 2016B Bonds shall be substantially in the form set forth in the Trust Loan Agreement and the Fund Loan Agreement, respectively.

<u>Section 4.</u> The terms of the 2016 Bonds authorized to be set forth by the Chief Financial Officer in accordance with Section 2 hereof shall be ratified by the affirmative vote of 2/3 of the full members of the Township Council.

<u>Section 5.</u> The full faith and credit of the Township are irrevocably pledged to the punctual payment of the principal of and interest on the 2016 Bonds and, to the extent payment is not otherwise provided, the Township shall be obligated to levy *ad valorem* taxes upon all taxable real property within the Township without limitation as to rate or amount for the payment thereof.

<u>Section 6</u>. Each of the Trust Loan Agreement, Fund Loan Agreement and the Escrow Agreement are hereby authorized to be executed and delivered on behalf of the Township by the Mayor or Chief Financial Officer in substantially the forms on file in the offices of the Township, with such changes as the Mayor or Chief Financial Officer in their respective sole discretion, after consultation with counsel and any advisors to the Township and after further consultation with the Trust and the State and their representatives, agents, counsel and advisors, shall determine, such determination to be conclusively evidenced by the execution of each of such Trust Loan Agreement, Fund Loan Agreement and Escrow Agreement by an authorized officer as determined hereunder. The Township Clerk and Deputy Township Clerk are each hereby severally authorized to attest to the execution of the Trust Loan Agreement, Fund Loan Agreement and Escrow Agreement, Fund Loan Agreement and Escrow Agreement by an authorized officer of the Township as determined hereunder and to affix the corporate seal of the Township to such documents.

Section 7. All actions heretofore taken and documents prepared or executed by or on behalf of the Township by the Mayor, Chief Financial Officer, Township Clerk, other Township officials or by the Township's professional advisors, in connection with the issuance and sale of the 2016 Bonds or the 2016 Project are hereby ratified, confirmed, approved and adopted.

<u>Section 8</u>. The Mayor, Chief Financial Officer and Township Clerk are each hereby authorized to determine all matters and execute all documents and instruments in connection with the 2016 Bonds or the 2016 Project not determined or otherwise directed to be executed by the Local Bond Law, the Bond Ordinance, or by this or any subsequent resolution, and the signature of the Mayor, Chief Financial Officer or Township Clerk on such documents or instruments shall be conclusive as to such determinations.

<u>Section 9</u>. All other resolutions, or parts thereof, inconsistent herewith are hereby rescinded and repealed to the extent of any such inconsistency.

Section 10. This resolution shall take effect immediately upon adoption this 14th day of March, 2016.

GT E-GOV ACCESS

Pete Heinbaugh of Morningstar Court asked the following:

Would you please explain Gloucester Township's Multiple Dwellings Commission? What is it's mission? Who are its members? When are its public meetings? Where are its meeting minutes? Does the Commission have a budget? Does this Commission interact with the Gloucester Township Housing Authority?

Mr. Cardis stated that this is a fund set up in the 1970's to protect the health, safety and welfare of apartment dwellers. He stated that anyone owning an apartment complex was required to pay a certain amount to the township that was put in an interest baring account. If any emergency repairs needed to be done at the complex, the township had the money to do these repairs immediately if the owner failed to do the repairs. He stated that once the money is expended it must be replaced by the apartment owner. Mr. Cardis stated that there has been no activity in these accounts for quite some time. The Mayor and Mr. Cardis are the only people on the committee and they do not meet and there are no minutes.

For purposes of property tax assessment, what is Gloucester Township's process for performing audits and/or inspections to verify when a property is claimed to be for farmland use? Mrs. Trotto read a statement prepared by the Assessor:

When property is claimed for Farmland use an application is made for Farmland Assessment, the owner must submit a plan of the farm showing what and where the farming will take place. Applications are due by the end of August each year.

In addition to the plan, the application must include income receipts derived from the farm products at least for \$1000 for the first 5 acres and \$5 per acre after the first 5.

In the case of woodland Management Farmland Assessment, income generated must be \$500 per acre and \$.50 per acre after the first 5. Woodland Management Farmland Applications must also be accompanied by a 10-year Forestry Management Plan prepared by the State certified forestor and also approved by the State.

The Township Assessor then inspects the properties and verifies all information each year by November 1 for approval or denial. Applications are then forwarded to the County Board of Taxation and the State Division of Taxation.

The Statutory requirement is that each farm parcel must be visited by the Assessor every 3 years. We visit at minimum every other year. Some farms are visited each year depending on the type of farming that is shown on the application. Further information and details can be obtained through the Assessor's Office.

PUBLIC PORTION:

Mr. Mercado opened the Public Portion.

Mr. Polidoro of Erial asked whether Waste Management is taking care of the township's solid waste now. Mr. Cardis stated that the township is not going automated as this would have been an expense outlay for the township. He also discussed the RCA center and questioned Council if there is any open land in the township or perhaps Lakeland for this facility to go. He stated that the problem with the facility for the residents was that it was too close to the college

Mr. Lechner commented on the Resource Recovery Center. He stated that the problem with the application is putting residential in an institutional zone.

Mr. Polidoro also discussed whether the e gov questions would be answered at the beginning of the meeting, if requested which he stated was agreed at a previous council meeting. Mrs. Trotto stated that she will discuss this with Mr. Mercado.

Mr. Brown of Erial asked whether the Premium Outlets had received their tax abatement. He also asked about the artificial turf and whether buying this artificial turf will result in a tax increase. Mr. Cardis stated that the money for the turf fields will mostly come out of Open Space. Mr. Cardis stated that the township will be using cork material for the fields as opposed to the rubber material.

There being no further comment, the public portion was closed.

POLLING OF COUNCIL:

Mr. Hutchison thanked everyone for attending the meeting.

Mrs. Schmidt congratulated the Police Department on National Night Out awards and thanked the residents for coming to the meeting.

Mrs. Stubbs congratulated Lt. Barton and Officer McLaughlin for all that they do and she stated that she appreciates their service.

Mrs. Winters congratulated the Police Department and stated that they do an amazing job. She also commented to Mr. Polidoro that a center is definitely needed in the township.

Mr. Mignone thanked all those involved with National Night Out. He thanked everyone for coming to the meeting.

Mrs. Trotto congratulated the officers involved with National Night Out and echoed the sentiments of Mrs. Winters regarding the need for a facility. She thanked everyone for coming to the meeting.

Mr. Hutchison made a motion to adjourn, seconded by Mrs. Winters. Roll call vote: All in favor. Motion carried. 6-0.
